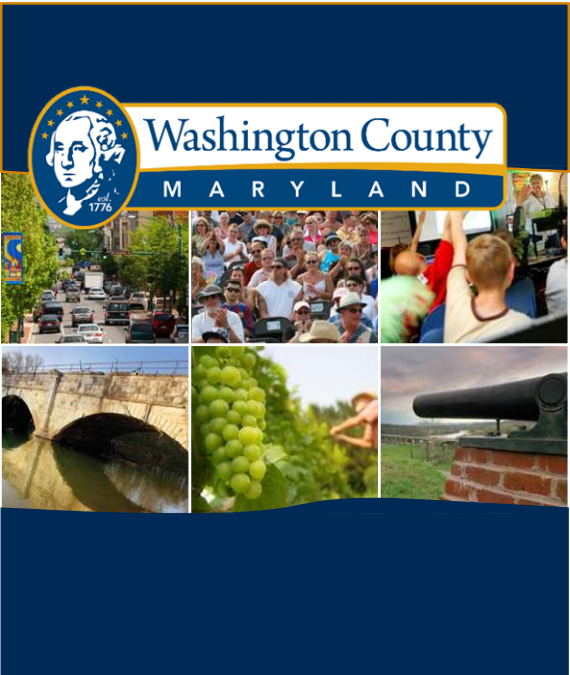
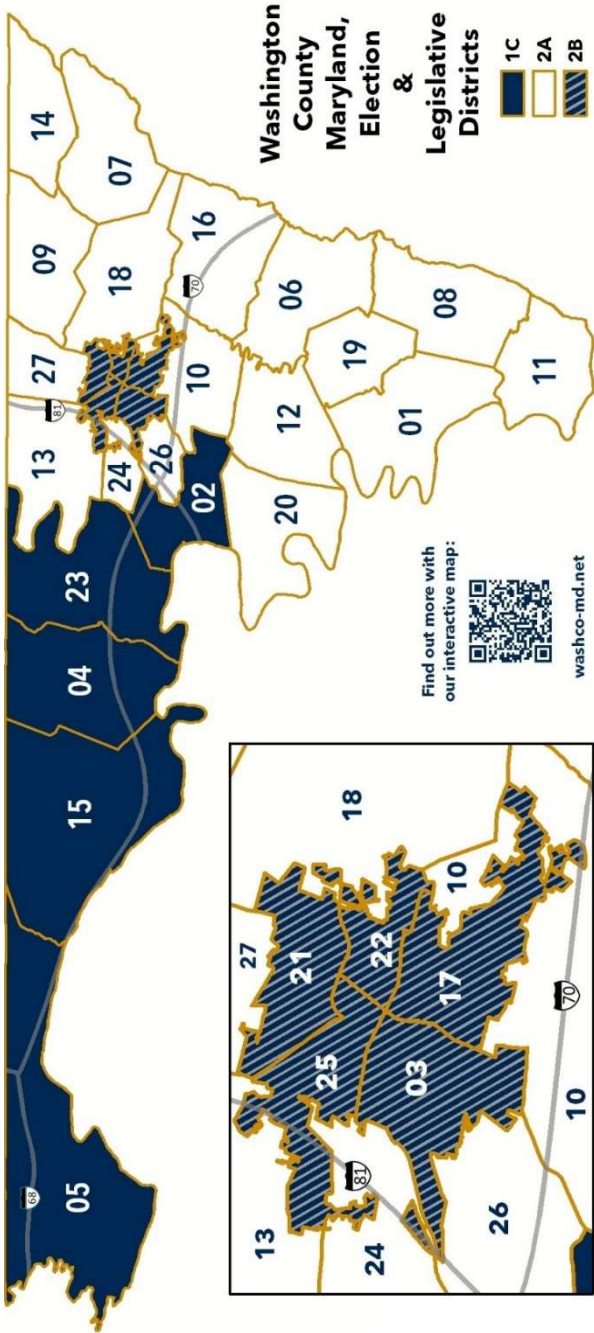

# Facts for Voters

## To register, you must:

- Be a U.S. citizen;
- Be a Maryland resident;
- Be at least 16 years old\*;
- Not be under guardianship for mental disability or if you are, you have not been found by a court to be unable to communicate a desire to vote;
- Not have been convicted of buying or selling votes;
- Not have been convicted of a felony, or if you have, you have completed serving a court-ordered sentence of imprisonment.

\* You may register to vote if you are at least 16 years old but cannot vote unless you will be at least 18 years old by the next general election.

## How to Register:

- By mail, online or in person at the Board of Elections or call 240.313.2050 for an application.
- Pick up an application at any post office, school, State agency or Motor Vehicle Administration when you apply for a driver's license, picture ID, change your address or change your name on your driver's license.
- First time voters in Maryland must provide their current Maryland driver's license or state ID number; if they do not have a driver's license, then and only then, the last four digits of their Social Security number for verification of identity.
- An application may be downloaded from the State website at [www.elections.maryland.gov](http://www.elections.maryland.gov). Mail the completed form to the Board of Elections.

You must register with a party if you want to take part in that party's primary election, caucus or convention.
